INTRODUCTION

- 1. This is the institutional report of His Majesty the King in right of Ontario ("Ontario") to the Public Inquiry into the 2022 Public Order Emergency declared by the Government of Canada and in effect from February 14 to 23, 2022 (the "POEC").¹
- 2. Ontario is not a party with standing before the POEC.² It submits this report and associated documentary disclosure further to a request from Commission Counsel and the statutory authority of a summons for documents and written information issued under the *Inquiries Act*.
- 3. Ontario's institutional report and documentary disclosure was prepared based on information and documents gathered from across government, and specifically from the provincial ministries most directly involved in the events surrounding the blockades and protests in Ontario in February 2022: the Ministry of the Solicitor General ("SOLGEN"), Ministry of the Attorney General ("MAG"), Ministry of Transportation ("MTO"), Ministry of Economic Development, Job Creation and Trade ("MEDJCT"), Ministry of Municipal Affairs and Housing ("MMAH") and the Premier's and Cabinet Offices which include the Ministry of Intergovernmental Affairs.

OVERVIEW OF KEY EVENTS AND ACTIVITIES BY ONTARIO

• January 23, 2022: protest groups under the umbrella name 'Freedom Convoy' begin to enter Ontario or travel within Ontario, in response to the COVID-19 vaccination policy for

commercial cross-border truckers that came into effect on January 15, 2022, among other grievances.

- January 28 and 29, 2022: 'Freedom Convoy' elements arrive in the Ottawa National Capital Region in large numbers and remain there.
- **February 7, 2022:** 'Freedom Convoy' elements form a blockade of the Ambassador Bridge border crossing between Windsor and Detroit.

• February 11, 2022:

- The Premier of Ontario declared a province-wide emergency pursuant to subsection 7.0.1(1) of the *Emergency Management and Civil Protection Act*, RSO 1990, c. E.9 ("EMCPA"). The declaration was filed as O Reg 69/22.
- The Chief Justice of the Superior Court of Justice made an order prohibiting the impeding or blocking access to the Ambassador Bridge, granted at the request of the Automotive Parts Manufacturers' Association and supported by the City of Windsor and the Attorney General of Ontario.
- **February 12, 2022:** The Cabinet of Ontario confirmed the Premier's declaration of emergency through an Order in Council, in accordance with subsections 7.0.1 (1) and (2) of the EMCPA, filed as O Reg 70/22. Under subsection 7.0.2 (4) of the EMCPA, Cabinet made the emergency order, "Critical Infrastructure and Highways", which was filed as O Reg 71/22.

• February 14, 2022:

The Premier of Ontario took part in a First Ministers' Meeting during which the Prime
 Minister expressed concern about the damage caused by the 'Freedom Convoy'

protests, including to international perceptions of Canada's business climate and Canadian's confidence in democratic institutions. The Prime Minister advised that the federal government was considering the use of the federal *Emergencies Act* to supplement measures already in place and to give law enforcement maximum leverage to deal with the unfolding situation.

- The Prime Minister advised that he considered the First Ministers' Meeting to be part of the provincial and territorial consultation that was required by section 25 of the Emergencies Act.
- Later that day, the Government of Canada declared a national public order emergency under subsection 17 of the *Emergencies Act*.
- **February 18, 2022:** The Ottawa Police Service ("OPS"), along with officers from the Ontario Provincial Police ("OPP"), Royal Canadian Mounted Police ("RCMP"), and other municipal forces, began removing 'Freedom Convoy' protesters and vehicles from the Ottawa downtown core. The police operation continued for several days thereafter.
- **February 23, 2022**: Ontario's declaration of emergency was terminated by Order in Council filed as O Reg 82/22. The federal declaration of emergency was revoked on the same day.
- February 24, 2022: The City of Ottawa's municipal state of emergency was terminated.
