I. OVERVIEW.

- 1. This Institutional Report is provided in response to the request of Commission counsel, dated August 3, 2022, and pursuant to Rule 51 of Commission's Rules of Practice and Procedure.
- 2. The report is divided into three parts:
 - i. Significant protest activity in Saskatchewan and the response to it.
 - ii. Consultations by the federal government with the Government of Saskatchewan relating to the invocation of the *Emergencies Act*.
 - iii. <u>Summary of evidence in relation to specific matters identified in Commission</u> counsel's correspondence dated August 3, 2022.
- 3. Core or background facts are related in each part, with attributed sources.
- 4. Notably, protest activity in Saskatchewan was able to be dealt with through authority that existed without the invocation of the *Emergencies Act*.
- 5. The Government of Saskatchewan did not place any requests for assistance to the federal government, and was not consulted regarding the *Emergencies Act* being invoked in Saskatchewan until February 14th, the day the public order emergency was proclaimed.
- 6. The Government has concerns regarding the impacts that implementing the *Emergency Measures Regulations*, SOR/2022-21, and *Emergency Economic Measures Order*, SOR/2022-22, had on residents of Saskatchewan. Information in this regard (for example, with respect to the freezing of residents' bank accounts) is expected to lie with other parties before the Commission, including the Royal Canadian Mounted Police ("RCMP"). In addition, the Government continues to make inquiries about these impacts, and as further evidence comes to light, it will be provided to the Commission.

II. SIGNIFICANT PROTEST ACTIVITY IN SASKATCHEWAN AND THE RESPONSE TO IT.

- 7. Protest activity in Saskatchewan in February of 2022 consisted of the following:
 - A "Freedom Convoy" protest in Regina, planned for the Legislative Building;
 - "Freedom Convoy" protests near the Regway and North Portal border crossings.
- 8. The Government worked cooperatively with the Regina Police Service and the RCMP in managing the protest activity.

(a) "Freedom Convoy" protest in Regina, planned for the Legislative Building.

- 9. The Government became aware that a trucker "Freedom Convoy" protest was planning to arrive at the Legislative Building, which is located in Wascana Centre, in Regina, on Saturday, February 5th. The protest was in relation to Covid-19 related measures, including vaccination requirements for crossing the Canada-U.S. border. The protestors' expressed intention was to occupy space on the Legislative grounds with their vehicles until what they considered a desirable resolution with respect to Covid-19 related measures was achieved.
- 10. A multi-agency group was formed to manage the response to the protest. The group included personnel from the Regina Police Service, the Ministry of Government Relations, the Provincial Capital Commission, the Ministry of Corrections, Policing and Public Safety (including the Safer Communities and Neighbourhoods program), the Ministry of Environment, the Saskatchewan Highway Patrol ("SHP"), the Ministry of SaskBuilds and Procurement, the Sergeant at Arms for the Legislature, and the Regina Emergency Measures Organization.
- 11. The Saskatchewan Provincial Emergency Operations Centre ("PEOC") of the Saskatchewan Public Safety Agency ("SPSA") coordinated meetings and provided situation reports for the group.

- 12. In advance of the convoy's arrival, barricades were set up at multiple vehicular entrances to Wascana Centre. The barricades prevented unauthorized vehicles from accessing Wascana Centre, where the Frost Festival, a winter festival, was operating from February 4th through February 10th. The barricades remained in place at those vehicular entrances until February 14th, at which time they were repositioned to allow increased vehicular traffic into Wascana Centre. The barricades were ultimately removed entirely on March 14th.
- 13. The barricades were staffed at different times by members of the Regina Police Service, SHP officers, conservation officers from the Ministry of Environment, special constables from the Provincial Capital Commission, and special constables under *The Safer Communities and Neighbourhoods Act*.
- 14. The situation reports provided by the PEOC describe the activity related to the protest, and are appended at **Appendix "A"**. In brief summary, the situation reports describe the following:
 - 01. **Sat, Feb 5, 2022, 08:00 hrs (SAS00000063):** Barricades were in place and staffed. The map on the report shows the location of the barricades.
 - 02. **Sat, Feb 5, 2022, 19:00 hrs (SAS00000075):** Convoy vehicles were organizing to block the right driving lanes of a loop of streets around Wascana Centre (Albert Street, College Avenue, Broad Street, 23rd Avenue), but leaving the left driving lane open for emergency vehicles. The Regina Police Service was monitoring the situation and developing a traffic plan.
 - 03. **Sun, Feb 6, 2022, 20:00 hrs (SAS00000099):** The Regina Police Service had ticketed vehicles which were parked on-street in violation of bylaws during the evening of the 5th. Protestors were upset and verbally abusive when ticketed. The police continued monitoring protestors and traffic, and were preparing for further enforcement.

- 04. **Mon, Feb 7, 2022, 18:30 hrs (SAS00000102):** Noted that the police had initiated their enforcement plan beginning at 7 p.m. on Sunday, February 6th, including by having tow trucks arrive. Most protestors had left by midnight, while the event organizer remained. Two tow truck companies were called to assist by the police, but one left after the event organizer instructed her friends/associates to bombard the companies with calls. The other company remained on scene and one vehicle was seized. A heavy hauler was on scene but was not needed. The police had issued parking tickets and some summary offence tickets.
- 05. **Tues, Feb 8, 2022, 16:30 hrs (SAS00000108):** Matters were quiet since dispersal of the protestors and the towing of the vehicle. Barricades remained in place.
- 06. Wed, Feb 9, 2022, 16:30 hrs (SAS00000111): No significant activity reported as having occurred.
- 07. **Fri, Feb 11, 2022, 16:00 hrs (SAS00000118):** No significant activity reported as having occurred. Plan was to move barricades on Monday, February 14th, to allow vehicular access to Wascana Centre, though still restrict the area around Legislative Building.
- 08. **Mon, Feb 14, 2022, 16:30 hrs (SAS00000124):** No significant activity reported as having occurred. Noted that protest activity appeared to be dwindling down in the Regina area, and that the focus seemed to have shifted to convoys/protests at or near Saskatchewan border crossings. Barricades had been moved back in Wascana Centre as depicted on the map in the situation report.
- 09. As aforementioned, the barricades were eventually removed entirely on March 14th.

- (b) "Freedom Convoy" protests near Saskatchewan border crossings at Regway and North Portal.
- 15. After the protest in Regina, protest activity occurred at or near Saskatchewan border crossings.
- 16. During the week of February 7, 2022, the SHP was contacted by Superintendent Woodrow of the RCMP, who requested SHP assistance regarding planned protest activity near the Regway and North Portal border crossings. The SHP was asked to provide back-up to the RCMP, as may be required, and assistance with commercial vehicle enforcement, being subject matter experts in same.
- 17. On February 10, 2022, the RCMP provided the Government a situation report containing information on the planned protests (**SAS00000113** and **SAS00000114**). These included a planned protest at the Port of Regway on February 12th, and a planned protest at the Port of North Portal on February 18th.
- 18. The SHP sent two officers to assist the RCMP at the Regway crossing on February 12th and 13th. On February 14, 2022, the RCMP asked for more SHP resources to assist in the coming days.
- 19. On February 15, 2022, the day after the proclamation of the emergency under the *Emergencies Act*, a briefing note prepared by the Ministry of Highways (**SAS00000025**) outlined the Government's position on the invocation of the Act and the SHP's involvement with protest activities. This briefing note is appended at **Appendix "B"**. It indicated that the Government did not support the invocation of the *Emergencies Act*, and that the SHP had been involved with manning barricades in Regina and provided two officers to support to the RCMP with respect to the protest activity. It also indicated that the SHP would send up to 17 officers to Estevan on February 18th to support RCMP enforcement activities related to the protest activity planned at the North Portal crossing.

- 20. On February 16, 2022, the SHP deployed a total of 19 personnel to assist the RCMP. These included 13 traffic officers, five sergeants and one inspector. The SHP personnel arrived in Estevan at 3 p.m. for an RCMP briefing and the first SHP shift began at 7 p.m.
- 21. On February 20, 2022, the SHP and RCMP began to scale back their deployments as the protest activity did not reach the magnitude initially anticipated. The SHP's involvement in supporting the RCMP concluded as of February 26, 2022.
- 22. The SHP produced daily briefing reports regarding its involvement from February 16th to February 20th. These are appended at **Appendix "C"**. In brief summary, the reports describe the following:
 - 01. **Wed, Feb 16, 2022, 16:00 hrs (SAS00000128):** Noted SHP emergency operations centre had been activated, 19 SHP officers had been deployed to assist the RCMP with operations at North Portal. Convoy had initially been expected to arrive on February 19th, but updated information suggested arrival on the 16th.
 - 02. **Thurs, Feb 17, 2022, 16:00 hrs (SAS00000133):** Noted approximately 70 vehicles were expected to arrive at North Portal that day, and that approximately 15 protestors (group from Yorkton) had set up camp on private property near the North Portal port of entry. These protestors were there with the permission of the property owner.
 - 03. **Fri, Feb 18, 2022, 16:00 hrs (SAS00000136):** Noted that a second camp may be set up by a different group in a field near a checkpoint. Border crossing and traffic delays expected. SHP officers noted to be collecting and running plates to provide information to the RCMP.
 - 04. **Sat, Feb 19, 2022, 16:00 hrs (SAS00000137):** Noted that "Southbound and Down" convoy headed for North Portal. A new group (Riedel group) had set up a camp in a field near a checkpoint, but were not expected to stay overnight.

- 05. **Sun, Feb 20, 2022, 15:00 hrs (SAS00000138):** Noted that "Southbound and Down" convoy did not reach the numbers anticipated, and that both the RCMP and SHP would be scaling back their deployments.
- 23. SHP officers were involved in three enforcement events during their time at the border:
 - SHP officers conducted two impaired driver (cannabis) investigations. One of the
 drivers was associated with the protest and the second was not. The RCMP took
 custody of the individuals from the SHP for further investigative steps.
 - The SHP placed one commercial vehicle out of service for equipment violations (loose wheel fasteners).
- 24. SHP officers acted pursuant to their authority which pre-existed the emergency order proclamation. This authority included that under *The Highways and Transportation Act*, 1997 and associated regulations, and the *Criminal Code*.
- III. CONSULTATIONS BY THE FEDERAL GOVERNMENT WITH THE GOVERNMENT OF SASKATCHEWAN RELATING TO THE INVOCATION OF THE EMERGENCIES ACT.
- 25. The first time the federal government indicated to the Government of Saskatchewan that it was considering invoking the *Emergencies Act* was on February 14, 2022.
- 26. On the morning of February 14th, an urgent telephone call with First Ministers, the Prime Minister and Ministers Mendicino, Lametti and LeBlanc was convened. No briefing material was provided by the federal government before the call.
- 27. The Government of Saskatchewan has provided the Commission with the notes of Trevor Holloway, Senior Intergovernmental Officer, who sat in on the call (**SAS00000120**).
- 28. Prime Minister Trudeau provided opening remarks, stating that the call was to hear from First Ministers regarding the *Emergencies Act* and that no final decision had been made

about the use of the Act. The Prime Minister indicated that if the Act were to be invoked it would supplement provincial and territorial jurisdiction, and it would be used to uphold the rule of law.

- 29. The Prime Minister indicated that he believed there was a national emergency and that if the federal government used the Act, it would not involve the military. However, the federal government could use other powers to do things such as restrict border protests and compel tow truck drivers to work. Minister Lametti discussed how the Act could be used in this regard. Minister LeBlanc suggested that the federal government wanted to support provinces and territories. The Prime Minister then asked the Premiers to share their view on the use of the Act.
- 30. Premier Silver (Yukon) indicated support and asked if the Prime Minister had spoken to other federal party leaders.
- 31. Premier Cochrane (Northwest Territories) suggested the situation was an ethical dilemma and indicated support, while noting there was no current need for the Act in the territory.
- 32. Premier Horgan (British Columbia) noted the province had sent RCMP resources out-of-province to assist with circumstances, and indicated support for use of the Act.
- 33. Premier Kenney (Alberta) spoke about the Coutts border crossing and indicated that the protest had diminished to approximately 40 more committed and potentially violent protestors. Premier Kenney suggested using the Act would inflame matters and risk further agitating people who are not currently protesting to begin protesting, and suggested that provinces can already compel tow truck drivers to act. Premier Kenney suggested the trucker vaccine mandates should be suspended by the federal government.
- 34. Premier Moe (Saskatchewan) discussed the current protests in Saskatchewan, including at the Regway border crossing. Premier Moe suggested that police can deal with protestors with existing tools like mischief charges and that governments need to look at starting to lift public health measures.

- 35. Ministers Lametti and Mendicino suggested that there was a need to protect critical infrastructure and that measures could be targeted to allow law enforcement additional tools.
- 36. Premier Stefanson (Manitoba) indicated concerns that use of the Act could escalate or inflame matters. Premier Stefanson suggested there was a need to plan for easing border requirements and public health measures.
- 37. The Prime Minister indicated that border blockades are about more than Covid-19 and that there was a need to protect public safety and order, in addition to issues with the blocking of critical infrastructure.
- 38. Premier Akeeagok (Nunavut) noted no direct impacts in the territory but noted the importance of ensuring the delivery of food supplies.
- 39. Premier Ford (Ontario) spoke about the significant costs of the border blockades to the Ontario economy and the impacts they were having on critical sectors and livelihoods. Premier Ford indicated support for the use of the Act.
- 40. Premier Legault (Quebec) acknowledged the situation in Ottawa but indicated that in Quebec the police were managing. He suggested if the federal government used the Act, it should not apply in Quebec.
- 41. The Prime Minster noted the situation in Ottawa was impacting the whole national capital region, and that the Act would not be used where it was not needed.
- 42. Premier Higgs (New Brunswick) indicated that a nation-wide invocation of the Act would inflame matters.
- 43. Premier King (Prince Edward Island) noted the situation in the province was stable, and had concerns about inflaming matters by invoking the Act.
- 44. Premier Houston (Nova Scotia) noted the province did not currently have problems, and that the use of the Act could inflame matters.

- 45. Premier Fury (Newfoundland and Labrador) noted the concerns about inflaming matters, but suggested that protestors do not represent the vast majority of people, and that the protests can no longer be tolerated. Premier Fury indicated support for the use of the Act.
- 46. The Prime Minster noted concerns about further inflaming and needing a path to the lifting of public health measures, and indicated a follow-up letter would be sent to Premiers.
- 47. After the call, at approximately 1:06 p.m., Premier Moe tweeted the following (SAS00000016):

"The illegal blockades must end, but police already have sufficient tools to enforce the law and clear the blockades, as they did over the weekend in Windsor.

Therefore, Saskatchewan does not support the Trudeau government invoking the Emergencies Act.

If the federal government does proceed with this measure, I would hope it would only be invoked in provinces that request it, as the legislation allows."

- 48. Premier Moe also sent a text message to federal Minister LeBlanc which reiterated what he had conveyed during the First Ministers' call.
- 49. Later in the day Prime Minister Trudeau announced that the federal government was invoking the *Emergencies Act*.
- 50. During the late evening on February 15th, correspondence was sent from Prime Minister Trudeau to Premier Scott Moe. This correspondence (**SAS00000037**) explained the federal government's rationale in declaring a public order emergency under the *Emergencies Act*.
- 51. Other communications regarding use of the *Emergencies Act* following its invocation are detailed in Part IV of this report.

IV. SUMMARY OF EVIDENCE IN RELATION TO SPECIFIC MATTERS IDENTIFIED IN COMMISSION COUNSEL'S CORRESPONDENCE DATED AUGUST 3, 2022.

- 52. Commission counsel has requested that Saskatchewan summarize its evidence in relation to information received and provided at a number of meetings which occurred before and after the public order emergency was proclaimed on February 14, 2022.
- 53. The following tables are provided, in addition to the matters previously addressed in this Institutional Report.

(a) Meetings of the FPT Crime Prevention and Policing Committee (FPT CPPC): Feb 1, 7, 11, 16.

2022.02.01	The following was noted at this meeting:
	 Since January 15, 2022, all commercial vehicle operators entering Canada from the U.S. were required to be vaccinated. Since January 22, 2022 all commercial vehicle operators entering the U.S. from Canada were required to be vaccinated, under U.S. law. An over 90% compliance rate had been observed with all measures including vaccination among cross-border operators.

2022.02.07	The agenda for this meeting (SAS0000011.0001) including an item
	entitled "Update on the situation in Ottawa".
	Federal Deputy Minister of Public Safety Rob Stewart stated:

- There was now an injunction in place regarding the protest in
 Ottawa for the police to enforce. He advised that there did not
 appear to be any significant element of violent extremism going on.
- The police have not been able to control the sounding of horns and lawless behaviour in downtown Ottawa.

John Ossowski, President of the Canada Border Services Agency (CBSA) stated:

- In Alberta, one lane was open and protestors remained, but traffic was getting through.
- Ambassador bridge between Windsor and Detroit blocked. CBSA working to share intelligence, but it comes down to enforcement by police.

Michael Keenan, Deputy Minister of Transport Canada stated:

- Many in Ottawa do not think they are breaking the law, and are surprised when police are enforcing. If participants know that they will be subject to major fines and their commercial vehicle operations may be at risk, they may reconsider.
- Want to have aligned enforcement across the country.
- Challenge in having tow truck industry cooperate.

Various officials from the provinces spoke.

- Alberta indicated that the police had the legal tools to respond to the protests, and were determining how to apply them.
- British Columbia indicated that the police will act proactively to prevent a circumstance as occurred in Ottawa.
- Quebec indicated that the police used the existing law to manage protests, and that it had worked.

 Nova Scotia indicated that the key was early discussions with police and organizers to prevent escalation.

Marlin Degrand (Assistant Deputy Minister, Alberta) described the protests in Alberta:

- Traffic continued to be blocked at 2 sites: (1) Coutts; (2) Milk River.
- Various protest tactics were being used at other sites, including slow roll convoys.
- Police trying to prevent what occurred in Ottawa from occurring in Alberta.
- Police lack heavy lift capacity to remove vehicles.
- Tow truck industry not wanting to get involved.
- Have requested heavy lift capacity assistance from federal government.

Rick Stubbings (Assistant Deputy Minister, Ontario) spoke:

- Ontario is looking to put in place provincial emergency measures, likely to go to Cabinet by February 12th, looking at what can be enacted to assist police and authorities (e.g., large fines).
- Have concerns with children at protest sites.
- Police have limited traffic in and around the provincial legislature.
- Possible protest at Rainbow Bridge in Niagara Falls on the weekend.

Dominic Rochon (Assistant Deputy Minister, Public Safety (Canada)) spoke:

- No specific leader or central entity directing protest activity.
- Protests taking form of civil disobedience and not sedition or terrorist activity.

• Exploring ways to maximize strategic law enforcement, through ticketing and arrests.

Aaron McCrorie (Associate Assistant Deputy Minister, Transport Canada) spoke:

- Advised that a document was being translated that would be shared early the following week, document would be in relation to strategic enforcement strategies for illegal occupations or blockades.
- Need to maximize enforcement under the *Criminal Code* and transportation legislation.
- Encourage police to lay charges, prosecutors to maximize penalties.
- Publicize charges and when demonstrators are fined.
- Have a strategy to procure tow trucks to assist in enforcement.

Haley Crichton (senior official, Nova Scotia) wrote in the "chat" feature of the online meeting that police with Class 1 licenses were being moved to the border in order to be able to move trucks if drivers were arrested.

Rob Cameron (Assistant Deputy Minister, Saskatchewan) wrote a question in the "chat" feature:

- "Will the document with "options" also contain a review or evaluation of the constitutional and statutory impacts or issues with the cross jurisdictional issues"?
- Response from Aaron McCorie "Rob, no. The way it is framed it's about using the authorities that you have within your jurisdiction."

2022.02.16

Meeting chaired by Takal Dakalbab (Assistant Deputy Minister, Public Safety (Canada) and Haley Crichton (senior official, Nova Scotia).

The invitation for this meeting went out on February 14th (**SAS00000018**), along with an attachment entitled "Illegal Occupation/Blockades: Strategic Enforcement Strategy", which was noted as a working draft, dated February 13th (**SAS00000019**). This is the document that was mentioned by Aaron McCrorie as forthcoming in the February 11th meeting. The document outlined a suggested strategic enforcement strategy in two parts: communications and enforcement. It did not address new powers pursuant to the *Emergencies Act*.

The meeting was originally scheduled for February 15th but was rescheduled to February 16th (**SAS00000029**). A summary of the meeting is as follows.

- Purpose of meeting was to provide an update since the proclamation of the emergency, address next steps, and any questions or concerns by the provinces.
- A briefing on the *Emergencies Act* and the new regulations and order was provided, indicating that they were intended to fill gaps in legislative authorities, and would be temporary.
- Would allow the direction of private agencies (towing companies) to remove blockades and infrastructure.
- Would allow for information and direction to be provided to financial institutions to prevent the funding of unlawful activities.
- Would allow designation of areas in advance of anticipated unlawful activity to restrict access.
- Noted that proclamation would be debated in the house and senate, 7 days to do so.
- Transport Canada (ADM McCrorie) stated that the fundamental intent of the measures is to communicate strongly that there will be consequences for unlawful actions.

- It was noted that the CBSA was already in the process of securing 25 key crossings and ports.
- During the roundtable, provincial officials had questions about matters including who would be authorized to act under the new powers under the *Emergencies Act*.

(b) Meetings of the ADM-level table of the Council of Ministers Responsible for Transportation and Highway Safety: Feb 4, 8.

2022.02.04

Meeting requested and led by Transport Canada. Invitation noted it was regarding potential mitigation measures in light of current trucking protests (**SAS00000008**).

- Purpose of the meeting was to have a better understanding of what was going on across the country, and how circumstances were being dealt with, what measures have been or could be employed.
- B.C. indicated that there were rolling protests occurring there and that police were dealing with them as they occurred. One traffic jam was caused for about 15 minutes.
- Alberta indicated that it was actively managing the situation at the Coutts border crossing, and that the RCMP have been managing the situation, but may not be able to resolve it. RCMP negotiations had led to some improved traffic flow.

- Saskatchewan advised that there was not a lot occurring in the province. A convoy may be arriving at the Legislative grounds in Regina, and might stay for some time. Enforcement through ticketing would be a policing matter.

Canada (Privy Council Office) led this meeting and provided information,

The national situation remained precarious in spite of some progress over the past few days. Coutts, AB had been cleared, but Emerson, MB was still blocked. Ottawa had less protestors than on the weekend, but there was little progress from the weekend, and some participants were noted to have weapons.

- The Act was invoked to provide additional tools for police to use. A
 brief description of these was given (e.g., ability to prevent access to
 areas identified as critical infrastructure, compel tow trucks to assist,
 disrupt financing of unlawful activity by freezing accounts).
- Confirmed in response to a question from Manitoba that Cabinet met on Sunday night (Feb 13) to discuss the potential use of the Act.
- Indicated that three incident response group meetings had been chaired by the Prime Minister since Thursday (Feb 10).
- Indicated that on Sunday it became clear that more authority would be needed.
- Indicated that the financial measures needed to be able to be enforced Canada-wide.
- Indicated that police would be able to provide a list of participants to banks for them to stop operations with particular accounts.
- Indicated that documents would be tabled in Parliament, and use of the Act would be debated.

Information related from the provinces included:

- Manitoba indicated that the first mention of the *Emergencies Act*being considered was during the First Minister's call, and in media
 reports, and questioned the adequacy of the consultation, indicating
 that what occurred was not similar to the consultation which occurred
 in 2020 (re: Covid-19). Manitoba questioned how the blockade at
 Emerson was beyond police capacity without invoking the Act.
- Alberta indicated that the Coutts blockade was largely resolved before the *Emergencies Act* was invoked.

- This meeting was an opportunity to provide an update on the emergency proclamation and the opportunity to ask questions.
- It was noted that late Tuesday evening (15th) the Premiers were each sent a letter explaining the federal government's rationale for having invoked the *Emergencies Act*, and that debate had commenced in the House of Commons regarding the Act's invocation.
- The federal officials indicated that they would be sending two documents out which had been placed before the House, the first dealing with the rationale for invoking the Act and the second dealing with consultations which had occurred beforehand. These documents were sent the next day, February 18th.

- Manitoba asked if there were any active border closures, and the federal official(s) indicated that there were not.

(e) FPT Meeting of the Ministers responsible for Justice and Public Safety: Feb 23.

2022.02.23 After a welcome and introductions on February 23rd, the first substantive matter addressed was an update on circumstances surrounding the use of the *Emergencies Act*. This was led by Federal Public Safety Minister Mendicino.

- Minister Mendicino indicated that on advice from law enforcement, the federal government had to create new tools under the *Emergencies Act* for use in a time-limited, concentrated way.
 Minister Mendicino indicated that law enforcement could designate "no-go" zones near critical infrastructure, commandeer equipment like tow trucks and freeze financial accounts. He also indicated that the federal government didn't want to use the *Emergencies Act*, but that it was necessary.
- Concerns were expressed from Quebec that the legal obligation to consult with the provinces and territories had not been satisfied by the meeting on February 14, 2022.
- Manitoba agreed with Quebec and suggested regional application of the Act rather than national application could have been used.
 Manitoba noted that the police could deal with circumstances there under existing legislation, without the *Emergencies Act*.
- Alberta indicated that additional RCMP resources from B.C. were used to resolve the Coutts blockade, but everything that needed to be done could be done under provincial legislation and the *Criminal Code*. The federal proclamation was not needed in Alberta.
- Nova Scotia indicated that redeployment of officers from Nova Scotia to Ottawa left the province short on officers, and that more consultation was required before the *Emergencies Act* was used.
- British Columbia indicated that they were fine with the consultation that took place and agreed with the use of the *Emergencies Act*.

• Minister Lametti indicated that he believed the consultation requirement was met and that he was prepared to defend how it was done. He indicated that consultation included all interactions with police, officials, and ministers. In his view, the order supplemented police powers and did not take them away from the provinces or territories. He indicated that the ongoing use of the Act was being evaluated in real time.





SASKATCHEWAN RESPONSE TO INVOKING THE EMERGENCY ACT

ISSUE

• Saskatchewan Highway Patrol (SHP) activities related to trucker protests.

KEY MESSAGES

- Saskatchewan does not support the federal government's choice to invoke the Emergencies Act (Act)
- The SHP has been activated as part of the Provincial Response Team (PRT) by the Royal Canadian Mounted Police (RCMP) to assist with enforcement activities at border crossings in Saskatchewan.
- The SHP has specific expertise in commercial vehicle enforcement and will primarily provide subject matter expertise to the RCMP at this time.
- Saskatchewan values the vital role of truck drivers in ensuring Saskatchewan goods get to market and that the province's people have access to the goods they need.

IMPACTS

- The current order is silent on the role of provincial law enforcement agencies, however, the RCMP could continue to request SHP support.
- Provincial law enforcement agencies could be provided with more tools to restore order, including the ability to levy fines and make arrests.
- Section 19(3) of the Act ensures Canada does not unduly impair a province's ability to take any emergency measures.
- Section 20 of the Act ensures Canada does not reduce the Province's or Municipalities' ability to control or direct law enforcement agencies.

BACKGROUND

- On February 14, 2022, the Government of Canada invoked the Act. The Act gives powers to the Prime
 Minister and his cabinet to respond to four different types of emergency scenarios: public welfare
 (natural disasters, disease), public order (civil unrest), international emergencies, and war emergencies.
- The public order emergency grants the government the authority to apply the following temporary measures:
 - Regulating and prohibiting public assemblies, including blockades, other than lawful advocacy, protest, or dissent;
 - Regulating the use of specified property, including goods to be used with respect to a blockade;
 - Designating and securing places where blockades are to be prohibited (e.g., borders, approaches to borders, other critical infrastructure);
 - Directing specified persons to render essential services to relieve impacts of blockades on Canada's economy;



Ministry of Highways

- Authorizing or directing specified financial institutions to render essential services to relieve the impact of blockades, including by regulating and prohibiting the use of property to fund or support the blockades;
- Measures with respect to authorizing the RCMP to enforce municipal and provincial laws by means of incorporation by reference; and,
- The imposition of fines or imprisonment for contravening on any of the measures declared under this public order emergency.
- Orders or regulations made by the Governor in Council pursuant to the Act shall be laid before the
 House of Parliament or to the Parliamentary Review Committee (PRC) within two sitting days after it's
 made or established.
- The PRC is made up of one member of the House of Commons from each party and at least one senator from each party in the Senate.
- The SHP has participated in provincial activities related to protests including staffing barricades at the provincial legislature.
- The SHP sent two officers to the Regway border crossing and the North Portal border crossing on February 12 and 13, 2022, at the request of the RCMP in response to protests planned at those locations.
- The SHP will send up to 17 officers to Estevan on Febyrary 18 as part of the PRT response to support RCMP enforcement activities related to a planned protest at the North Portal border crossing from February 18-21, 2022.
- Aviation may also be impacted nationally as a result of "slow roll" protests, which have been carried out in other jurisdictions interfering with access to airports.











NOTICE TO DEMONSTRATORS

Saskatchewan RCMP respects the rights of Canadians to protest and gather. We remind you it is within your right to assemble and use private property during those protests as long as no breach of peace occurs.

The Emergency Act prohibits public assemblies leading to a breach of peace, such as:

- . the serious disruption of the movement of persons, goods or serious interference with
- . the interference with the functioning of critical infrastructure; or
- · the support of the threat or use of serious violence against persons or property.

We wish to advise you that it is considered breaching the peace to park a vehicle on the side of any public highways or grid roads.

To avoid breaching the peace during your demonstration, we ask that you:

- · do not disrupt road traffic or access to border facilities in any way;
- · do not use violence of any type;
- · do not park your vehicle on the side of any public roads;
- . do not park your vehicle on any private properties you do not have approval to use by

If breaches of peace occurs and protests become unlawful, our police officers are allowed to use all enforcement measures at their disposal, including the Emergencies Act, to restore peace and traffic on our roads. This can lead to demonstrators being arrested, vehicles being seized and towed, vehicle insurances being suspended, and personal bank accounts being frozen.
